Rules Governing This Department: Please Read All Rules Carefully

- A. Livestock entries are due to the Senior Fair Board Office by June 10th 2023.
- B. NO ONE is permitted in the Barn until Thursday (before Fair) @ 7:30pm
- C. Market hogs must have been farrowed after January 1st of the current year.
- D. All hogs must be castrated by May 1st.
- E. Each exhibitor may show only three market hogs, as long as one is a registered purebred.
- F. Exhibitors must furnish own bedding (shavings) It is the responsibility of the exhibitor to keep the pen(s) clean the entire week.
- G. Exhibitors that have 2 pigs will have 1 pen, 3 pigs will have 2 pens.
- H. Exhibitors must furnish 1"x6"x4'8" kickboards on all pens along aisles.
- I. Market hogs will be weighed and tagged Saturday, July 23rd from 7:30 a.m. to 12:00p.m. Each exhibitor must be with his/her own animals at this time. Hogs must weigh between 220 300 lbs to show and sell in Jr. Fair Sale.
- J. Any hog not making weight must be removed from the fairgrounds by 10:00 p.m. on the Saturday of weigh-in.
- K. No ice water or oil based products may be used on hog projects.
- L. Exhibitors have 1^{1/2} hrs after completion of livestock show to pull animal from sale. Sale Representatives will be at podium in show ring. If not pulled by 6:00, all remaining projects will be required to be sold through the Junior Fair Livestock Sale. Both the exhibitor and the parent/

- guardian must sign the Livestock Auction Removal Agreement.
- M. Weight classes for market hogs will be divided evenly into classes. A Champion and Reserve Champion will be selected for the divisions. The Division Champions and Reserve Champions will in turn show for the overall Grand and Reserve Champion market hogs with Top 5 Purebreds.
- N. Divisions or classes may be subdivided at fair time if number of entries in any one class is too large for show area.
- O. Grand Champion and Reserve Champion Hogs must sell at livestock sale on Saturday. These hogs are terminal.
- P. All hogs not going though the Jr. Fair sale need to be removed from the fairgrounds
 Tuesday night, after the Jr. Fair Show. All pigs remaining on the grounds will go to the packer.

NOTICE FOR SECTION 1 & 2

- No One is permitted in the Barns until 7:30pm on Thursday
- All shows will have purebred classes.
- Only 2 pigs per exhibitor will go through the auction however the 3rd pig is eligible to go on the packer truck.

Rules for Section 2

- A. Registration Certificates for all Purebred Market Hogs are REQUIRED from respective Breed Assn.
- B. Original Certificate Required. No Copies Accepted, this will be shown at time of weigh-in.
- C. Registration certificates must be in Exhibitors name as owner, transferred by entry due date.
- D. All purebred market hogs to be ear notched. (Universal System)
- E. Breed Purity Verification by Sr./Jr. Fair Board.
- F. All market hog entries not meeting the purebred requirement will be permitted to enter as a crossbred, unless it is the exhibitors 3rd pig, at which time it is disqualified, as exhibitors are limited to a maximum of 2 crossbred entries. Animal will need to be removed from the fairgrounds by Saturday night of weigh-in.
- G. A minimum of 3 entries is required per breed or they will show crossbred. (Section 1)
- H. The champion of the Crossbred Section will be eligible for Overall Champion.
- Purebred or composite breeds not recognized by the Ohio State Fair Breeds will not be eligible for AOB classification.
- J. Class 12 is for those who are undecided on breed.

Rules for Market Show:

- A. All market hogs entered into the Butler County Born & Raised hog show must be the progeny of a sow that resides in the county. The hog must be born and raised in Butler County or a county school district.
- B. The exhibitor must be a Butler County Junior Fair member.
- C. The hog must be in the possession of and in the care of the exhibitor by May1of the current year.
- D. The hog must be purchased directly from a Butler County swine breeder, no second party sales.
- E. All Butler County Born & Raised hog show exhibitors will follow the same rules listed in the Jr. Fair Market Hog Show.
- F. Premiums will be determined by number of entries and will be prorated by class.

Rules for Purebred Market Hog Show:

- A. Registration Certificates for all Purebred Market Hogs are required from respective Breed Assn.
- B. Original Certificate required. No Copies Accepted
- C. Certificates will be presented to the BCBR Show Manager or appointed Assistants at check-in time on Saturday Morning of the Butler County Fair.
- Registration Certificates must be in Exhibitors name as owner or co-owner, transferred be entry due date.
- E. All Purebred Market Hogs to be ear- notched (Universal System)
- F. Breed Purity Verification by BCBR members
- G. All Market Hog entries not meeting the purebred requirement will be permitted to show as crossbreds.
- H. A Minimum of 5 entries is required per breed or they will show as an AOB class.
- Premiums will be offered for AOB Division

- J. The champion of the AOB Division will be eligible for Overall Champion.
- K. Purebred or composite breed not recognized by the Ohio State Fair Recognized Breeds will not be eligible for AOB classification.
